The appointment order in this proceedings is purely provisional under Rule 9(a) (1) of KS & SSR for a period of one year from the date of joining duty or till a regular PSC hand joins duty whichever is earlier. The appointment is liable to be terminated at any time without further notice.

The candidates is directed to report duty before the Regional Deputy Director, Insurance Medical Services (SZ) Kollam within 15 days on receipt of this order.

All candidates are directed to produce necessary certificates (including original caste certificate) before Regional Deputy Director at the time of reporting duty.

If the particulars furnished by the candidates in employment office at the time of registration are found incorrect or the nomination of name from the employment office is not found in order, the appointment will be terminated after giving reasonable chance to the incumbent for furnishing explanation.

The candidates should furnish declaration at the time of joining duty to the effect that they have no objection in the termination of their service if it is proved that the particulars furnished by him/her in the employment office is found incorrect or the nomination and selection of candidate for appointment were found not in order.

The candidate should produce another declaration to the effect that he/she has no objection on the termination of the service on expiry of a period of one year or as and when PSC hand joins duty whichever is earlier. Both the declaration should be forwarded to this office without fail.
